  - A. CONSIDER ADOPTING AN ORDINANCE AMENDING CHAPTERS 1282.05(b)(3)(c)(2) AND CHAPTER 1282.05 (b)(2)(f)(2) TO INCREASE THE PERMITTED SIZE OF WALL SIGNS IN THE SHOPPING CENTER AND COMMERCIAL DISTRICTS TO 25 SQUARE FEET.

CONSIDER ADOPTING A RESOLUTION AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO THE PENNSYLVANIA DEPARTMENT OF CONSERVATION AND NATURAL RESOURCES FOR THE CONSTRUCTION OF A PASSIVE PARK ON THE NEWSOM PROPERTY. THE GRANT AMOUNT REQUESTED IS \$282,500. THE TOWNSHIP'S PORTION OF THIS PROJECT IS \$282,500 FOR A TOTAL PROJECT COST OF \$565,000. THIS PROJECT WILL COMPLEMENT THE STREAM STABILIZATION WORK THAT WILL BE DONE IN WEIR PARK LATER THIS YEAR.
  - D. CONSIDER A MOTION TO SUBMIT A GRANT APPLICATION TO PENN DOT FOR A GRANT IN THE AMOUNT OF \$762,000, FOR THE IMPLEMENTATION OF A STREETScape PLAN ALONG PENNELL ROAD FROM DUTTON MILL ROAD TO CONCORD ROAD. THE TOWNSHIP'S PORTION OF THE PROJECT WILL BE \$192,000 FOR A TOTAL PROJECT COST OF \$960,000.
