#### **1. Call Meeting to Order**

Chairperson Carol Graham called the meeting to order.

#### **2. Approve the Minutes of the Meeting Held on May 3, 2012**

Chairperson Graham asked for a motion to approve the May 3, 2012 meeting minutes.

Kit Spayd made the motion and Maggie Berry second the motion. All parties were in favor and the meeting minutes were approved.

#### **3. Smiles in the Playgrounds / Discussion / Sub Committee**

Kit Spayd notified the committee of an event going on at the Freedom Playground. The event will run from 10:00am to 2:00pm at 3500 Darby Road in Haverford, Pennsylvania. Kit feels this type of event would help give committee members insight into the direction of the Smile in the Playground Program. #### **4. Recap of Lewis H. Fisher Memorial Park Clean Up**

#### **5. Christmas Tree Lighting Ceremony December 7, 2012**

Maureen Dillon has started the preliminary planning for the event. She is currently working on securing storage for the items the committee created last year, a stage for the children's choir performance, and unique cut outs for taking pictures. It was suggested that the committee reach out to the Eagle Scouts and Penn Delco School District to see if they would be interested in taking these on as projects.

#### **6. Discuss Potential Movie Night During Summer**

Aston Resident Matthew Kelly stated he was interested in helping get this project up and running. He offered many different suggestions and possible avenues to turn this event into one that could appeal to many different age groups. He was tasked by Committee Chairperson Graham to come up a preliminary plan for the event.

Chairperson Graham asked the committee to organize the communications into a central database along with coming up with a standard format for use by the committee. It was agreed that the committee will utilize the software each individual feels most comfortable with and work further to organize communication.

Bowden also asked that the township draw up a donation request letter in advance for the Christmas Tree Lighting Event.
