PROCEDURES & APPLICATION FOR OBTAINING A RESALE CERTIFICATE IN
ASTON TOWNSHIP

1. This application must be completed in its entirety. All questions must be answered and the fee must be submitted prior to any inspections occurring. Any incomplete applications will be returned.
2. The fee for this application is \$100.
3. Applications should be submitted to the Aston Township Code Department.
4. Once the completed application is received the inspection process will consist of the following:
 - a. A property history search for open permits, open complaints and zoning conformance.
 - b. A public curbing and sidewalk inspection of the property.
 - c. A notarized affidavit submitted with this application confirming that Smoke Alarms, CO Alarms (Carbon Monoxide) and visible house numbers are present or will be present at time of transaction. The affidavit must be signed by the seller and buyer. The seller signature would need to be notarized.
 - d. In the case of an "AS IS" sale, the buyer will sign both seller and buyer portions of affidavit. The buyer will need to have this signed and notarized.
5. Once completed the results of these inspections will be e-mailed to the applicant and the seller or buyer (depending on the sale type) will be responsible for correcting any violations found.
6. In order to correct any public curbing and sidewalk violations a permit will be required.
7. When said permit is obtained the permit holder is responsible for scheduling an inspection prior to the concrete being poured, as well as scheduling a final inspection once the work is completed and the area is restored to an acceptable condition.

IF WORK IS NOT COMPLETED WITHIN 12 MONTHS, A CITATION SHALL BE ISSUED TO THE NEW PROPERTY OWNER.

THE WORK MUST BE INSPECTED BY A TOWNSHIP INSPECTOR BEFORE POURING CONCRETE. CALL THE CODE DEPARTMENT 48 HOURS IN ADVANCE TO SCHEDULE AN APPOINTMENT.

Smoke detectors must be installed, one (1) in every bedroom, one (1) outside each sleeping area, one (1) on every level of the building including the basement, one (1) carbon monoxide detector outside each sleeping area, as well as in the bedroom if a fuel burning appliance is located within. This is in compliance with the adopted International Residential Code.
